The purpose of the ASSOCIATION is

 promoting the development and popularization of vocational education in Ukraine, professional growth of the teachers who are capable to carry out their professional activities on the basis of humanism, democracy, free competition and high technologies, in the process of their constant improvement as well as to provide continuous education of citizens implementing practical educational policy as a priority function of the state, also the realization and protection of the rights and freedoms, satisfaction of professional, scientific, social, cultural and other interests of the ASSOCIATION members.



- promoting the development and popularization of vocational and continuous education in Ukraine;
- assistance in strengthening and improving the training of highly qualified specialists for the vocational education system;
- assistance in establishing creative and professional contacts between institutions of higher education, institutions of postgraduate pedagogical education, scientific institutions of the National Academy of Pedagogical Sciences of Ukraine, public pedagogical organizations, etc.;
- promoting the creation of the proper conditions for active professional activity of its members;



- in accordance with the legislation of Ukraine, participation in the formation of vocational and continuous education policy in Ukraine, including the development of draft legislation, draft state concepts, strategies for the development of vocational and continuous education in Ukraine and their implementation;
- promoting the development of the Union members' potential and their activities in the territory of the country, expanding the opportunities for their professional development



- assistance in providing advisory and methodological assistance in matters of vocational education and continuous education to members of the Union, other organizations and institutions;
- promoting the creation of databases on vocational and continuous education and the dissemination of this information in Ukraine and other countries;
- promotion of national, regional, interregional and international congresses, conferences, symposia, seminars, round tables, exhibitions, fairs and other events (winter and summer school) on vocational and continuous education;
- assistance in the organization of international cooperation on the development of continuous pedagogical education, in particular, exchange of experience, implementation of joint educational and research projects



- assistance in the implementation of research and information and educational activities;
- assistance in providing information support to the statutory activities of the Union;
- promoting cooperation with international governmental and non-governmental organizations, educational institutions in the field of vocational education of other countries, including the implementation of joint international projects and programs;
- in accordance with the legislation of Ukraine, assistance in the publication of methodological, reference, informational and other materials; disseminating information about their activities and promoting their purpose.
